POSITION OVERVIEW

The Technology Policy Advisor develops and advances the organization's positions on technology and AI policy. This role analyzes policy and regulatory developments, advises leadership on their implications, and supports the organization's engagement with policymakers and stakeholders.

Working with legal, government affairs, governance, and business leaders, the Technology Policy Advisor turns a complex policy landscape into clear strategy and positioning, and helps the organization contribute constructively to policy debates.

As technology policy shapes the environment in which the organization operates, the advisor helps it stay informed, principled, and effective in how it engages.

- Analyze technology and AI policy, legislation, and regulation.
- Advise leadership on implications and strategic options.
- Develop the organization's policy positions and principles.
- Anticipate policy trends and their business impact.

Track and interpret developments across areas such as:

- AI regulation, including the EU AI Act
- Data protection, privacy, and cybersecurity policy
- Standards and frameworks such as the NIST AI RMF
- Sector-specific and cross-border technology rules

- Support engagement with policymakers and regulators.
- Coordinate participation in consultations and industry groups.
- Prepare position papers, comments, and briefing materials.
- Represent the organization's views clearly and accurately.

INTERNAL ADVISORY

- Advise governance, legal, and business teams on policy questions.
- Translate external policy into internal implications and actions.
- Support leadership and Board briefings on policy matters.
- Align policy positions with organizational values and strategy.

CROSS-FUNCTIONAL COORDINATION

- Coordinate policy work across government affairs and governance.
- Align internal stakeholders on positioning and messaging.
- Support responses to policy-related inquiries.

DOCUMENTATION AND HORIZON SCANNING

Maintain policy analysis, positions, and a horizon of upcoming developments to keep the organization prepared.
